

OFFICIAL RULES OF THE ROSENBERG RAILROAD MUSEUM, INC.

2009 FUNDRAISING RAFFLE

By entering the Rosenberg Railroad Museum, Inc.'s ("ROSENBERG RAILROAD MUSEUM, INC.") Fundraising raffle (the "Raffle"); you consent to be bound by these Official Rules. Accordingly, you should read these rules carefully before entering the Raffle.

- 1) **ORGANIZATION CONDUCTING RAFFLE:** The Raffle is being conducted by ROSENBERG RAILROAD MUSEUM, INC., which is solely responsible for the Raffle, the administration of these Official Rules, and the awarding of the prizes. Net proceeds from the Raffle will be distributed to ROSENBERG RAILROAD MUSEUM, INC.
- 2) **ELIGIBILITY:** To be eligible to enter the Raffle, you must comply with these Official Rules, be 18 years of age and either be a resident of Texas or purchase your ticket in person in Texas.
- 3) **HOW TO ENTER:** You have not entered the Raffle until your entry submission, with full payment, has been accepted by ROSENBERG RAILROAD MUSEUM, INC. Acceptance of your entry submission will be communicated to you by delivery of a ticket stub or written confirmation letter from ROSENBERG RAILROAD MUSEUM, INC. If a submission is accepted, then it will be deemed to have been accepted on the date and time on which the submission was received by ROSENBERG RAILROAD MUSEUM, INC., regardless of the date that ROSENBERG RAILROAD MUSEUM, INC. notifies you of the acceptance of your submission. You may enter as often as you want, but all entry requirements must be met for each entry. Tickets will be sold up until the final drawing on the night of the event, December 6, 2008. There are four ways to submit your entry:
 - a. **Submission by Internet:** Access the official ROSENBERG RAILROAD MUSEUM, INC. website at www.RosenbergRRMuseum.org ("Raffle Website"), navigate to the Raffle entry page, and complete the Raffle entry form by providing all requested information and then clicking "submit". Entry via the Internet will not be available for those who reside outside of a limited geographical region within Texas. Online ticket purchase will close at 5 :00 pm on December 1, 2008.
 - b. **Submission by Person:** Purchase your ticket in person from an authorized volunteer or staff person of ROSENBERG RAILROAD MUSEUM, INC. by completing the official entry form, and handing the completed entry form, along with check, money order, cash or credit card information, to one of the ROSENBERG RAILROAD MUSEUM, INC. volunteers/representatives.
 - c. **Submission in Phone:** Purchase your ticket over the telephone from an authorized volunteer or staff person of ROSENBERG RAILROAD MUSEUM, INC. by providing entry and payment information to the volunteer. Order tickets by phone by calling (281) 633-2846.
 - d. **Purchase Tickets by Mail/Fax:** Purchase your tickets by mail or fax from the ROSENBERG RAILROAD MUSEUM, INC. by completing the official entry form, and mailing/faxing the completed entry form, along with payment or payment information (i.e. credit card information) to the ROSENBERG RAILROAD MUSEUM, INC. , PO Box 369, Rosenberg, Texas 77471 or by fax at (281) 342-2936, Attn: Fundraising Raffle.
- 4) **COST:** The donation price of a single ticket is \$5.00. Checks or money orders should be made payable to ROSENBERG RAILROAD MUSEUM, INC. Credit card payments may be made on the ROSENBERG RAILROAD MUSEUM, INC. website at www.rosenbergrrmuseum.org or by filling out the credit card form and submitting to a ROSENBERG RAILROAD MUSEUM, INC. volunteer or staff member. All entries paid for by check or credit card will be held until check or credit card is cleared/approved. Once approved, tickets will be placed in the locked raffle drum. If the bank dishonors an entrant's check, the entry ticket will be declared invalid and removed from the raffle.
- 5) **ODDS OF WINNING:** The odds of winning the prize will depend upon the number of entries. Odds may be more favorable depending on the number of entries.
 - a. The drawing will be on Saturday, December 5, 2009 at 7PM at the Christmas in Rosenberg Event.
- 6) **PRIZES:** The prize cannot be substituted by the winner. ROSENBERG RAILROAD MUSEUM, INC. reserves the right to substitute a prize of equal or greater value, at its discretion.

 - d. The winning ticket will be determined by random drawing. The drawing date will be Saturday, December 5th, 2009 at the Christmas in Rosenberg Event. The drawing will be at 7PM. Christmas in Rosenberg is held in the historic downtown district of Rosenberg. The winner need not be present to win. The winner will be notified by telephone and email if given.
 - e. ROSENBERG RAILROAD MUSEUM, INC. makes no claims regarding the deductibility of raffle tickets, please consult your tax advisor or accountant.
 - f. In no event will ROSENBERG RAILROAD MUSEUM, INC. or its board members, agents or employees (collectively, "sponsors") be liable for any damages or losses or any kind, including direct, indirect, incidental, consequential, statutory or punitive damages. Without limiting the foregoing, with respect to the raffle and to the prize, the sponsors make no warranty of any kind, either expressed or implied, including but not limited to the expressed or implied warranties or merchantability or fitness for a particular purpose.
 - g. The value of the prize is based upon good faith estimates by ROSENBERG RAILROAD MUSEUM, INC. as of the date the Raffle was commenced. The Sponsors assume no responsibility for changes in market conditions that may impact the value of the prize. There is no guaranty that a winner will be able to sell the prize for the estimated value or that the IRS, or its counterpart in any state's jurisdiction, will accept the value of the prize for purposes of determining any tax that may be due by the winner.
 - h. Entrants hereby fully release the Sponsors from any and all liability caused by or resulting from the use or possession of any prize awarded or caused by or resulting from participation in the Raffle or any related promotion.
 - i. ROSENBERG RAILROAD MUSEUM, INC. assumes no responsibility for lost, late, misdirected or undelivered entry submissions, or any error, delay, or interference with entry via the Raffle Website.
- 8) **EXTENSION OF RAFFLE:** At ROSENBERG RAILROAD MUSEUM, INC.'s sole discretion and option, the dates for the drawing may be extended by no more than sixty days.
 - 9) **DISPUTE RESOLUTION:** Venue of any action brought concerning the Raffle shall be in Rosenberg, Texas/Fort Bend County, and shall not be subject to transfer to another venue or locale for any reason. By entering the Raffle, you agree that you will not commence or participate in any class action litigation, or join with any other person in a legal proceeding, concerning the Raffle. The Raffle, these Official Rules, the entire relationship between you and ROSENBERG RAILROAD MUSEUM, INC., and any legal proceeding arising there from (whether based on contract, tort, law or equity), shall be governed by, construed in accordance with, and enforced pursuant to, the laws of the State of Texas, without regard to its conflict of laws principles. Submission of a raffle entry constitutes your agreement with these Official Rules.
 - 10) **AMENDMENT OF RULES:** If, for any reason, the administration, security, fairness, or integrity of the Raffle has been compromised, ROSENBERG RAILROAD MUSEUM, INC. reserves the right, exercisable at its sole discretion, to cancel terminate, modify or suspend the Raffle. The Official Rules may be amended by ROSENBERG RAILROAD MUSEUM, INC. in its sole discretion. Amendments will be posted on the Raffle Website. Unless otherwise specified, any amendments will become effective at 12:00:01 a.m. CT on the day after they are posted on the Raffle Website.
